Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation® that the medications listed in the above tables are **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

A. Neuropathic pain (must meet all):

1. Prescribed indication is FDA-approved or supported by standard pharmacopeias
2. Failure to no less than a 30 day trial of at least two medications in separate pharmacologic classes not requiring prior authorization unless any of the following:
 - a. Allergy to medications not requiring prior approval

- b. Contraindication to or drug interaction with medications not requiring prior approval
- c. History of unacceptable/toxic side effects to medications not requiring prior approval

Approval duration: 12 months

II. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policy – CP.CPA.09 CP.PMN.53 for Medicaid or evidence of coverage documents.
